Eligibility Requirements

(All of the following requirements must be met.)

1. Applicant's school must have completed the Foundation's 2017-2018 Collision Repair School Solutions Survey.
2. Nominated student and instructor must be able to attend SEMA 2017 in Las Vegas. The award will cover two nights of hotel each for the instructor and for the student, airfare (or mileage if driving), and meals. The student/instructor will be required to attend the Education Foundation's reception at 9pm on Tuesday, October 31st and the instructor roundtable on Wednesday, November 1st at 9:00am.
3. Nominated student must be currently studying collision repair/refinishing at a school.

Grant Rules and Regulations

1. All entries completely filled out with all attachments must be mailed, faxed or emailed and received by the Education Foundation by 9/22/17 to be eligible. The Education Foundation is not responsible for late, lost, or misdirected mail.
2. There is a limit of one nomination per collision instructor so it recommended the instructor reflect carefully on who he/she chooses for the award nomination.
3. The winner will be chosen and notified by phone and mail in early October 2017. One award will be given.
4. Except where prohibited, the winner's name and likeness may be used for publicity purposes for this or similar promotions without additional compensation.
